- b. The TDOE School Nutrition audit was successful on March 1st according to our auditor. We are waiting on the final results from the state.
- c. After school tutoring began February 20th for 3rd 5th grade students and will continue for 7 weeks.
- d. I would like to thank Mrs. Finnie for reading to our Kindergarten and irst-grade class for Read Across America Week. We also had college students from Christian Brothers University to read. The students had an awesome time!

- f. Our professional development with Raven Hawes, our math consultant is doing an awesome job with our teachers. She has worked with our teachers and has given positive feedback from what she has seen. Our PD was cut short last Friday due to the power outage and will resume after Spring Break.
- g. I will attend the National Charter School Conference in San Antonio, TX June $18^{th} 21^{st}$. This conference brings in some of the top educators, advocates and leaders from around the world to share their best practices and lead conversations that will challenge your thinking. I would also like to see how other charters are funding their schools and to learn as much as I can about the charter world.

C. Facilities Update

All ESSER 2 budgeted funds must be spent, and forms completed by April 14th. Any quotes, contracts agreements, or PO's must be processed by this date. We have about \$200,000.00 to spend or this money will be returned to the state.

We are continuing to have a problem with the roof, and we are not able to get in touch with Phoenix Roofing Company. We are in touch with Mr. Dewayne Jones to see if he can repair this problem.

We have gotten 3 quotes for the boiler and hot water tank.

Memphis Air Conditioning and Heating Co. - \$5,720.00 for the boiler only Gipson Mechanical Contractors - \$83,161.00 Choate's Commercial HVAC Plumbing and Refrigeration - \$95,062.32

If we receive the Facilities Grant, we can use some of the funds to cover the HVAC from the grant. We are also waiting on a call from our School Board representative to see if she will be able to assist with funding.

Dr. Dee has submitted the grants that she is working on for this month. She will continue to report her findings each month.
