- a. Happy New Year! I hope everyone had an awesome holiday and was able to get some much need rest and was able to spend it with family and friends.
- b. The results of our priority status from the state are finally in. We are OFF the Priority List!!!!! Our students and teachers worked very hard in helping us to get off this list. We are excited about our progress. The priority status is based on student growth and it shows that our students are growing and are making gains. We received a B on the school report card and we are striving and working hard to keep this momentum going.
- c. Moolah Wireless is a tech company that solves the problems of mobile accessibility and wireless connectivity for under-represented/under-resourced communities by leveraging federal assistance programs to eliminate the cost of devices for at-need individuals. Each student will receive a free tablet with the parent's consent to use at home. They are expected to deliver these devices by the end of the month.
